FIRST ORDER OF BUSINESS

Call to Order

Mr. Brizendine called the meeting to order and performed the roll call.

SECOND ORDER OF BUSINESS

Consideration of Minutes of the Board of Supervisors' Meetings on June 4, 2012 and June 12, 2012

On a Motion by Mr. Andrews, seconded by Ms. Bell, with all in favor, the Board of Supervisors approved the minutes of the Board of Supervisors' meetings on June 4, 2012 as presented for Meadow Pointe IV Community Development District.

It was noted that a correction needed to be made in the motion box under the fifth order of business. Mr. Brizendine stated that he would research who made the motion and have the minutes corrected accordingly.

On a Motion by Mr. Bell, seconded by Mr. Andrews, with all in favor, the Board of Supervisors approved the minutes of the Board of Supervisors' meetings on June 12, 2012 as amended for Meadow Pointe IV Community Development District.

THIRD ORDER OF BUSINESS

Consideration of Operation and Maintenance Expenditures for June

There were no questions relating to any of the expenditures.

On a Motion by Ms. Bell, seconded by Ms. Andrews, with all in favor, the Board of Supervisors approved the Operation and Maintenance Expenditures for June totaling \$38,075.18 as presented for Meadow Pointe IV Community Development District.

FOURTH ORDER OF BUSINESS

Consideration of Pay Applications

Mr. Sifford presented requisitions #543-#546, stating that they total \$4,461.64 with \$2,712.84 being the District's portion of these expenses.

FIFTH ORDER OF BUSINESS

Public Discussion on Fiscal Year 2012/2013 Budget

Mr. Brizendine stated that this is the portion of the agenda that was set aside for the Board to address any comments or requests from residents relating to the budget. However, there are none in attendance. He noted that there have been no changes made to the budget since approved last month and it has been submitted to the County for inclusion in the County TRIM notices that will go out in August. Mr. Brizendine asked if the Board had any questions relating to the budget. There were none.

SIXTH ORDER OF BUSINESS

Consideration of Proposal for Additional Irrigation Repairs

Mr. Brizendine reviewed a proposal from Complete for additional irrigation repairs to bring the system up and running properly. The repairs consist of replacing a number of the drip lines and several rotors.

Mr. Brizendine explained that the District has spent \$6,475 on irrigation through May and the total budget for the year was \$8,894. Mr. Brizendine recommended that the balance of the expense be taken out of the mulch budget or other minor line items that have not been used this year. A brief discussion ensued regarding the timing to install mulch given it really should be installed after any plantings are installed or the rainy season ends. Mr. Blakley sought and received confirmation that enough money was included in the 2012/2013 budget to cover the mulching if they hold off until next year.

Mr. Brizendine stated that the current landscaping contract calls for the contractor to replace any above ground irrigation issues at their cost, but that was not the case with the prior contractor. A recommendation was made that a monthly check on the system be completed to ensure that Complete is keeping up with this requirement.

On a Motion by Mr. Bell, seconded by Mr. Andrews, with all in favor, the Board of Supervisors approved the proposal from Complete totaling \$10,752.40 for additional irrigation repairs and authorized Staff to utilize funds allocated for mulch to pay for the project for Meadow Pointe IV Community Development District.

SEVENTH ORDER OF BUSINESS

 Mr. Brizendine reported that the Skimmer repairs have been completed.

Mr. Crawford responded to a question regarding pressure washing, stating that the project will be scheduled shortly and he anticipates that it will be done before the next meeting.

Mr. Sifford reviewed the extensive documents that have been compiled and will be copied onto a CD for presentation to the Surety and a conference call that was held to verify that everything was included. He stated that Mr. Straley will be in contact with the Board should it become necessary to initiate mediation if they dispute the claims. A brief discussion ensued regarding whether this is a normal process. Mr. Sifford confirmed that mediation would be binding.

Mr. Sifford stated that State Road 56 matter did not make it to the June BOCC agenda.

E. District Manager

Mr. Brizendine stated that the District has now collected just over 100% of the assessments placed on the tax roll based on the sale of tax certificates and have collected the assessments due from restructuring the bonds.
